Recruit Holdings Announces Determination of Terms of Stock Options

TOKYO, JAPAN (July 25, 2022) - Recruit Holdings Co., Ltd. (TSE: 6098) (the “Company”) announced today that the undetermined items regarding stock options (Recruit Holdings Co., Ltd. Series 7 Stock Options) for Directors of the Board, excluding Outside Directors, Corporate Executive Officers, and key management personnel that were resolved at its Board of Directors meeting held on July 8, 2022 have been determined as follows.
